

Library of Things Procedure & Lending Agreement

Library of Things (LoT) items may be checked out for three weeks with two renewals. **LoT items must be picked up and returned at the Lynnfield Public Library Circulation Desk.** By borrowing an item in the LoT collection, a patron assumes full responsibility for an item. All patrons must sign the lending agreement for the items listed below. Patrons under the age of 18 will need a parent or guardian to sign the agreement before checking out items.
